We have been very grateful to Alan for his valuable help over the last year as we work to employ a Mission Enabler for our Deanery. Alan has been replaced by Rev Steve Robinson who has come from his job as Rector of Illogan Parish. We are pleased to welcome him as part of our team and are grateful for his help.

At the beginning of June, Rev David Saunders came to work in the Deanery as Rector of the Bude Coast and Country Benefice and in September he was able to join us on the DIT. This was a huge step forward for the team and David's experience in business will be a great advantage to us.

#### **GREAT NEWS - MISSION ENABLER**

Progress on the Mission Enabler Post

We advertised the Mission Enabler post at the end of last year and were happy to attract a very suitable candidate who was appointed but then had to withdraw for family reasons. This was a great disappointment but then it turned out that Rev Mark James was leaving about the same time and this made a big difference to the state of readiness of the Deanery to become an employer anyway.

As the Deanery is not a legal entity able to be an employer, one of the DIT's jobs has been to establish a Community Interest Company to be known as Stratton Deanery Community Interest Company (CIC). This has proved to be a far more arduous task that anyone expected but seems to be nearly ready now.

Rev David Saunders has agreed to be the Managing Director of the CIC and this means that we can now engage HR and Payroll services in order to become an employer for the Mission Enabler's Post. (Phew)

As a result we intend to formally readvertise the post at the beginning of October with the hope that a successful candidate may be able to start work assisting parishes across the Deanery in January 2025.

#### Who's paying for the Mission Enabler?

The Mission Enabler Post is being financed by the Truro Diocese Lower Income Communities Fund (LICF) and this has been available to us since 2023. As we did not use this money last year, the Deanery obtained permission to share the funds drawn down (£24,000) between the parishes as a one off payment for the sole purpose of supplementing their MMF Payments for 2024. This money has been distributed now and should be paid into the MMF in addition to the usual payments that parishes are making. If no appointment is made in 2024 to fill the Mission Enabler's post, suggestions will be sought for ways to spend this year's LICF funding on new development projects in the Deanery
